# Dues Schedule

## Provisional Member

Provisional membership is open only to companies that have never been AGC members. Provisional member dues are \$1,200 for two years, after which time the membership will be converted to Full Member status. Dues are billed annually.

## Full Member

A Full Member is a company that is state licensed as a general contractor. Dues are determined by using the company's previous year's total work volume/sales. National dues for full membership in AGC of America are included. Dues are billed quarterly.

## Associate Member

All members who do not qualify as full member, such as suppliers and service providers and subcontractors who are not state licensed as a general contractor are considered associate members. Annual dues based on a calendar year: \$725.
